Old Business

The tax arrears auction was successful in the sale of 218 Centre Street. Finalization will be handled through Orval Shantz' law office.

Preliminary floor plans were looked at for a new Administration office. Councillors would like to hold off until the new Council is sitting to make a final decision. Tender documents will be finalized to show to the new Council.

The Regional Enhancement Funding application will be presented to County of Newell Council on Monday by Y Cosh.

K Ramer has asked if Duchess will remove the caveat that is currently on her title in regards to the raw waterline that runs from Rock Lake to the Village of Duchess. Council discussed this and are agreeable if there is no cost to the Village and Ramers will release the Village of all obligations in regards to air relief valves, the water line and any other components of the water line. Council would like O Shantz to act on Duchess' behalf.

G McKenzie had also enquired about removing the caveat on his land in regards to the raw water line from Rock Lake.
